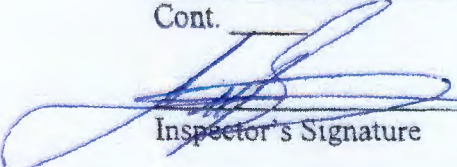

An inspection was conducted at Wendy's restaurant based on a complaint received on 10-3-2016 concerning rats inside & outside of establishment during my inspection I encountered rat droppings present inside boxes of ketchup also on storage area floor also roaches present in establishment roach was present inside Smoothie machine and crawling on walls in establishment I issued a Cease & Desist and Citation ordering closure of establishment until violations are rectified violations are as follows

- 1) Abatement of Nuisance 1404-69 Employees opening establishment and not cleaning rat droppings and discarding boxes of ketchup with rat droppings, also strong urine odor in dining area.
- 2) Unsanitary Conditions 1404-142 Kitchen area floors walls in unsanitary manner grease build-up on floor behind ice machine mold build-up between walk-in freezer door trash on floor in storage area.
- 3) Accumulations Prohibited 1404-53 Establishment is kept in an unsanitary manner employees disregarding trash on floor.
- 4) Insect Pest Violation Chp. 57.1571 2(b) Rats present in establishment rat droppings present in boxes of ketchup and on kitchen floor see attached photos

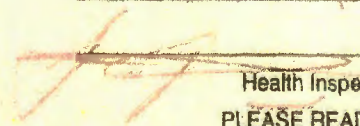
