Dear Honorable Committee Members:

I have reviewed my transcript and school completion audit (*attached*) and my explanation on the degree discussion is as follows:

I have completed the course-work in the Fall of 2014 for a Master's Degree in Professional Counseling. The course work ended with the comprehensive exams; which I passed, on the first try—an accomplishment that is note-worthy in this field. When asked by Senator Forde why there was a date of 2014 with regards to the degree; in my mind, I thought he understood that this is a Mental Health Degree and was asking about the two parts of the degree process. Hence, that was what I was answering to.

The internship is a requirement for licensure and I have also completed the minimum 600 hours requirements for that as well. Although licensure at the Master's level is not available in the United States Virgin Islands, I began the process in Virginia and thought that it was fit to complete the internship here.

I stated "pending" on the commissioner's application (*attached*) because I registered to continue my internship here in the U.S. Virgin Islands when I relocated. I felt it was a way for me to begin giving back immediately to our community with my counseling skill. I have been counseling a group of adolescents at a local counseling center after work since arriving in St. Croix.

Although I have completed the requirements for the internship portion, it is not reflected because the term has not ended. Notwithstanding, I am still in completion of the graduate requirements as shown in the Audit Report stating "Graduate". The next window of diploma processing will be in September and my diploma will be sent then.

I sent a request to Liberty, asking that my conferment process begin since all of my requirements have been met. Upon receipt of that approval, I will send it to you. I do hope that the wait will not have to be until September, but as it stands today, all of the requirements on my part for a Degree at the Master's level for this degree, have been met. That primarily, is what I was answering to.
